The paper analyzes the role of cooperatives in overcoming the food crisis during the World War I, their contribution to the economy development and the society stabilization. The author states that cooperatives produced and traded in mass demand goods in close cooperation with the city food authorities, partly with the help of state subsidies and benefits. As the problem of the shortage of goods was getting worse, the distribution functions of cooperatives were increasing. It led to the increasing financial and administrative dependence of cooperatives on the state and distortion of the nature of the cooperative movement.
